INFRASTRUCTURE, LEARNING RESOURCES AND ALLIED FACILITIES

1. Central Library: (Timing: 9 am to 5 pm.)

The College has a well maintained library which provides about 29,316 nos. Books, 13 Journals, 10 Periodicals and News Papers. The library also provides e-resources specially e-journals and e-books. The college Library is well automated, the SOUL 2.0 software is used for the library services. The barcode facility also enhanced the library services. The library has a good numbers of ICT tools for maintaining the Library works. It has a good number of computers, printers, scanners, Xerox machines. The entire library is under CCTV camera surveillance.

The Central Library provides circulation services, internet service, photocopies, current awareness service, newspaper clipping service, video graphic service and reference service etc.

The Central Library gives a best Library user award among the students from 2018 onwards.

Rules

- ☐ The students must be in college uniform along with identity card while visiting to the library.
- ☐ All students of the College are regarded as members of the library.
- ☐ Library Cards are issued to all the students.
- ☐ Books may be borrowed by students for a period of 10 days only. There is no provision of re-issue of the same book to the same person on same day. A fine of Rs. 1 per day per book will be charged if the students failed to return within stipulated time.
- ☐ A student is not entitled to borrow book against the library card of others. If detected he/she will be punished.
- ☐ Each Final year student must return his/her library books along with the library card before getting the admit card of the final examination.
- ☐ If the borrowed book is lost or damaged by any student the same must be replaced by new books by the concerned student. Students found, mutilating library books or periodicals or magazines will be subjected to disciplinary action.
- ☐ Mobile phones should be switched off in Library.
- ☐ Each student from B.A. or B.Sc. Honours Programme will be issued 4 books only for the period of 10 days.
- ☐ Higher Secondary students can borrow 2 books for the period of 10 days.

2. Computer Centre

The College has a well-equipped computer centre having over 30 computers with internet connectivity and uninterrupted power supply.

3. Modern Infrastructure Facilities

There are 13 digital classrooms and one Seminar Hall and one Conference Hall with all modern gadgets.

4. Indoor Games Facilities

The indoor games facilities like Carom, Table tennis, Chess etc. are available in the college premises.

5. Gymnasium

A state of art gymnasium equipped with modern exercising gadgets and equipment

backed up by professional staff are available.

6. Hostel

The college has a secured girls' hostel within the premises with 32 seat capacity. Application forms are available at the college office during the time of admission. Selection of students are purely based on merit.

7. Canteen

The college canteen provides refreshment to the students as well as faculty at a subsidized rate within the campus.

8. Day Care-Centre

The college has a Day Care Centre (10'×20') to facilitate all the employees of the college.

STUDENTS SUPPORT SERVICES

1. Students Mentoring system

Students mentorship programme enable constructive interaction, guidance and mentorship of students by their teachers. The vision of the programme is to monitor overall progression of the students right from the beginning of the 1st Semester till the end of 6th Semester.

2. Students Aid Fund

This fund was initiated by the college in 1970 for the economically weaker regular students of general category.

3. Career Counselling Cell :

The Career Counselling Cell is involved in organizing various oriented programme and workshop to felicitate students for career advancement for desired profession from time to time. All the department are also actively involved in guiding students in their specific field of interest.

4. Group Insurance Scheme for students

There is a provision of Group Insurance Scheme under LIC (GIS) run from the contribution of Rs. 23.00 made by each of the students per year. Under this insurance scheme a student is given coverage up to Rs. 20,000.00 in the event of major injury or death.

5. Grievance Redressal Cell :

This cell aims to render academic as well as non-academic grievances of students within the campus of the college.

6. Gender Sensitization Committee against Sexual Harassment (GSCASH) :

This committee try to aware the students about the gender discrimination and to mitigate the issues pertaining to sexual harassment.

7. Scholarships

According to the Government guidelines the college offers several types of scholarships to the deserving students which include National Merit Scholarship, State Merit Scholarship, Scholarship to ST/SC/OBC/MOBC & TGL students, Special Scholarship for the children of political sufferers.

8. Awards for brilliant students

a. The Chakreswar Saikia Memorial Award :

This award is given by the college every year in the memory of the founder principal Late Chakreswar Saikia to the best graduates securing first class in the B.A. and B.Sc. final examinations.

b. The Ratneswar Dutta and Mandakini Dutta Memorial Award:

This award is given every year to the student who secures highest marks in science stream of H.S. Final examination from Titabar Assembly constituency. The Award is given from the Bank Interest of the fund of Rs. 60,000/- deposited by the family of Late Ratneswar Dutta and Mandakini Dutta.

c. The Sampriti Mahila Kosh Award:

This award is given to the girl students of both Arts and Science streams who have secured highest marks in the degree final examinations.

d. Award from Nanda Nath Saikia Mahavidyalaya Sanchay Aru Rindan Samabay Samiti Limited:

The best Arts and Science graduates are awarded a sum of Rupees 5000.00 (Five thousand) each from the Samabay Samiti of the college in recognition of their academic excellence.

In addition to these several departments of the college offered awards to brilliant students.

CO-CURRICULAR ACTIVITIES

NATIONAL SERVICE SCHEME (N.S.S.)

There is a full-fledged NSS unit in the college which is an Indian Government sponsored public service programme conducted by the Department of Youth Affairs and Sports of the Govt. of India. It has 100 (one hundred) volunteers who are trained to understand their community and society where they belong to. The volunteers are engaged in different camps and programmes specially Blood Donation camp, Health and Sanitation Camp, Awareness Programmes, Relief Camps, Plantation Programmes and so on. Volunteers are also encouraged to participate in various cultural activities. Interested students can join and serve the society through these schemes.

NATIONAL CADET CORPS (NCC)

The college has introduced NCC 51 Assam Air(T) Senior division/Senior Wings in the year

2010-2011 with an intake capacity of 50 cadets. Till date our cadets has attended various camps which helped them in a broader way to lead a regimented way of life and in developing camaraderie, team work, leadership qualities, self-confidence, self-reliance and dignity of labour. Some of our cadet had participated in the Republic Day Programme and actively involved in various programmes related to social welfare and national buildings.

COURSES OFFERED FOR B.A. (HONOURS) /B.Sc. (HONOURS) UNDER FYUGP IN CHOICE BASED CREDIT SYSTEM (CBCS), 2023:

The Four-Year Undergraduate Programmes (FYUGP) in Choice Based Credit System (CBCS), 2023. These Regulations shall be effective for the Courses of Study leading to a UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research).

Definition:

- (i) UG Certificate programme: UG Certificate Programme leads to a UG certificate after completing 1 year (2 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG certificate (in the Field of Study/Discipline) after securing the requisite 44 Credits on completion of Semester II if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the stipulated maximum period of seven years.
- (ii) UG Diploma Programme: UG Diploma Programme leads to a UG diploma after 2 years (4 semesters) of study in the chosen fields of study. Students on exit shall be awarded UG Diploma (in the Field of Study/Discipline) after securing the requisite 88 Credits on completion of Semester IV if, in addition, they complete one work based/skill based 5 vocational course/internship of 4 credits within one year from the completion of 4th semester examination. These students are allowed to re-enter the degree programme within a period of three years and complete the degree within the maximum period of seven years.
- (iii) Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 3-year (6 semester) UG programme shall be awarded UG degree in the Major discipline after successful completion of three years, securing a minimum of 132 credits. Provision of double Major shall be implemented in due course of time.
- (iv) Four Year UG Programme with honours (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the Major discipline after successful completion of four years, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.
- (v) Four Year UG Programme with honours with Research (BA, B. Sc, B. Com and Bachelors in other disciplines) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours and research degree in the Major discipline after successful completion of four years with a rigorous research project, securing a minimum of 176 credits. Provision of double Major shall be implemented in due course of time.
- (vi) Programme: The term 'programme' is used to mean the whole learning experience or combination of courses pursued for a Certificate, Diploma or a Degree.

- (vii) Course: A “Course” means one of the specified units which goes to comprise a programme of study.
- (viii) Academic Year: An ‘Academic Year’ means a period of twelve months consisting of two semesters.
- (ix) Semester: The word “semester” is used to mean a half-yearly term or term of studies including examinations, vacations and semester breaks.
- (x) 9 In–semester: The word “in-semester” is used to refer to the continuous evaluation within the half-yearly term.
- (xi) End-semester: The word “end-semester” is used to refer to the terminal processes of examinations and evaluations at the end but within the half-yearly term.
- (xii) Credit: A ‘credit’ is a unit by which the coursework is measured. It determines the number of hours of instruction required per week over the duration of a semester (minimum 15 weeks). A course may have only a lecture component or a lecture and tutorial component or a lecture and practicum component or a lecture, tutorial and practicum component, or only practicum component. Credit shall be defined as below:

Academic Schedule: The Academic Schedule of the UG Certificate, UG Diploma, Three Year UG Degree, Four Year UG Degree (Honours) and Four Year UG Degree (Honours with Research) Programmes shall be administered as per the Academic Calendar of the University published for every academic session.

Minimum eligibility criteria for admission in Four Year Undergraduate programmes: Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.

Minimum eligibility criteria for multiple entry points of the UG programmes:

(a) **1st year:** Senior Secondary School Leaving Certificate or Higher Secondary (Class 12) Certificate obtained after successful completion of Grade 12 or equivalent stage of education and/or Admission test conducted by College/University/National Level Testing Agency/State Level Testing Agency.

(b) **2nd year:** A certificate obtained after successful completion of 1 year (2 semesters) of the undergraduate programme. These students are to take admission in the 2nd year within a period of three years from obtaining the UG certificate from Dibrugarh University or any other University/institution recognized by Dibrugarh University.

(C) **3rd year:** A diploma obtained after successful completion of 2 years (4 semesters) of the undergraduate programme. These students are to take admission in the 3rd year UG programme within a period of three years from obtaining the UG diploma from Dibrugarh University or any other University/institution recognized by Dibrugarh University.

(d) **4th Year (Honours):** A Bachelor's degree after successful completion of three years (6 semesters) of the Undergraduate programme obtained from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.

(e) **4th Year (Honours with Research):** A three-year Bachelor Degree with a minimum of 7.5 CGPA. The minimum entry requirement for 4th year (Honours/Research) UG programme within a period of three years from obtaining 3-year Bachelor Degree from Dibrugarh University or any other University/institution recognized by Dibrugarh University. These students are to complete the degree within the stipulated maximum period of seven years.

Four Year UG Programme with Honours (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the major discipline after successful completion of four years with Discipline Specific Elective Courses semesters in lieu of Research Project and Dissertation securing a minimum of 176 credits.

Four Year UG Programme with Honours with Research (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours with Research degree in the major discipline after successful completion of four years, with Research Project and Dissertation securing 176 credits.

Attendance

1.The Course Teacher shall be responsible for maintaining a record of attendance of students who have enrolled for the course.

2. All Course Teachers of college/institutions shall intimate the Principal/ Director of a college/ Institute through the Head of the Department concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.

In case of University Departments/Centre for Studies all course teachers shall intimate the Head of the Department/Chairperson of the Centre for Studies concerned at least thirty calendar days before the last instruction day in the semester, the particulars of all students who have less than 80% of attendance during the total number of class days.

3. A student who has less than 80% attendance in average shall not be permitted to sit for the End-semester examination. However, that it shall be open to the University to grant exemption to a student who has attended a minimum of 70% classes but failed to obtain the prescribed 80% attendance for valid reasons, on recommendation of the Head/Chairperson/ Principals of the Department/Centre/College on payment of a prescribed fee(s).

4. The Head of the Departments/Chairperson of the Centre for Studies/Principals of the Colleges shall announce the names of all students who shall not be eligible to take the End- semester examinations in the various Programs and send a copy of the same to the Controller of Examinations. Such candidates shall have to repeat the concerned Course(s) when it is offered next.

5. A student declared as dis-collegiate shall not be allowed to proceed to the next higher Semester. He/she shall need to pursue the Semester afresh in which he/she was declared as dis-collegiate along with the next fresh batch.

Examination and Evaluation:

- (a) Examination and evaluation shall be done on a continuous basis, at least two times during a Semester including the End Semester Examination.
- (b) There shall be 20% marks for in-semester assessment and 80% marks for End-semester examination in each course during every semester.
- (c) There shall be no provision for re-evaluation of the answer-scripts of the end-semester examinations. However, a candidate may apply for re-scrutiny.

In-semester Assessment:

- (i) In in-semester assessment, different tools such as objective tests, written tests, assignments, paper presentation, laboratory work, etc. suitable to the courses may be employed.
- (ii) The students shall be informed in advance about the nature of assessment. Students shall be required to compulsorily attend in-semester assessment including appearing the sessional tests, failing which they will not be allowed to appear for the End-semester examination. A Student cannot repeat In-semester examinations. The Department/Centre for Studies may arrange special in-semester examination whenever necessary.

End Semester Examination:

- (iii) There shall be one End semester examination carrying 80% Marks in each course of a Semester covering the entire syllabus prescribed for the Course. The End semester examination is normally a written/laboratory-based examination/Project Work/Dissertation.
- (iv) The Controller of Examinations shall make necessary arrangements for notifying the dates of the End semester examinations and other procedures as per Dibrugarh University Rules (at least 20 days in advance) and the Academic Calendar notified by the University.
- (v) The time given for End-semester examination for each Course shall be based on the credits/marks of the course.

- (vi) Emphasis needs to be given on problem solving, application-level questions as prescribed by National Education Policy, 2020. The question paper should include different forms of question.

Betterment Examination:

- i. A student shall be entitled to take the 'Betterment Examinations' in any two theory courses after successful completion of 3 year/4 year programme only once. In this case, the higher marks secured by the student shall be retained. The candidates shall have to apply for betterment examination within one year of passing the Sixth/Eighth Semester examination. Students shall have to appear in the betterment examination with the regular batch.
- ii. No betterments shall be allowed in the practical/project/dissertation/internship examinations.

Results and Progression:

1. A candidate shall be declared as passed a Programme, provided he/she secures-
 - At least 30% of marks in each Course in the End Semester Examinations combining both theory and practical examinations
 - At least 'P' grade in the 10 point scale combining both the in-semester and End Semester Examination performance.
 - There shall be no separate pass mark for In-semester Assessment.
2. A candidate shall be declared as passed a semester/ programme, provided he/ she secures at least 'P' grade in the 10 point scale (given in clause) in all the Courses separately.
3. There may be moderation of In-semester Assessment marks/End Semester marks as and when necessary.
4. The marks of In-semester examinations obtained by the candidate shall be carried over for declaring any result.
5. A candidate who fails or does not appear in one or more Courses of any end semester examinations up to fifth Semester shall be provisionally promoted to the next higher semester with the failed course as carry over course(s). Such candidates will be eligible to appear in the carryover course in the next regular examinations of those courses. If a candidate fails in any of the components (either theory or practical) of a course the candidate shall have to reappear in the examination for both the components.
6. If a candidate clears the sixth semester examination before clearing all the courses of the previous semesters, the result of the sixth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semesters.

7. A candidate who fails or does not appear in one or more courses of seventh semester examinations shall be provisionally promoted to the eighth semester with the failed course as carry over course(s). If a candidate clears the eighth semester examination before clearing all the courses of the seventh semesters, the result of the eighth semester examination of that candidate shall be withheld and his/ her results shall be announced only after he/ she clears the courses of the previous semester.
8. A student must clear all his/her Semester Examinations within six (6) years for three year undergraduate programme and seven years for four year undergraduate programme (with honours/research) from the dates of admission to the First Semester of any Programme irrespective of the number of examinations appeared by the student.
9. Since the Semester system involves continuous assessment, there shall be no scope for a student to appear as a private candidate in any programme in this system.
10. A candidate shall be declared to have passed provided he/she has passed all the Semesters and in all the Courses separately for the concerned programme.
11. The Controller of Examinations shall declare the results of different programmes and ~~the~~ Grade-sheets. ***The merit list shall be prepared only for the regular candidates and it does not include the backlog candidates.***
12. The first rank holder of a programme shall be decided on the basis of the CGPA. However, the Overall Weighted Percentage of Marks (OWPM) of a candidate shall be considered in case of tie in CGPA.
13. Results of the candidates appeared in the Betterment or Backlog Examinations shall not be counted for the award of Prizes/Medals, Rank or Distinction.

Provision of Multiple Exit:

Exit 1: There is a provision of exit after successful completion of 1 year (two semesters). A Certificate will be awarded when a student exits at the end of year 1 (2 semesters). Students who have secured minimum of 44 credits will be awarded a UG certificate (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 2nd semester examination.

Exit 2: There is a provision of exit after successful completion of 2 years (four semesters). A Diploma will be awarded when a student exits at the end of year 2 (4 semesters). Students who have secured minimum of 88 credits will be awarded a UG Diploma (in the field of study/discipline) if, in addition, they complete one work based/skill based vocational course/internship of 4 credits within one year from the completion of 4th Semester examination.

Exit 3: Three Year UG Degree Programme (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: There is a provision of exit after successful completion of 3 years (six semesters). Students who wish to undergo a 3-year UG programme shall be awarded UG degree in the major discipline after successful completion of three years, securing 132 credits.

Four Year UG Programme with Honours (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours degree in the major discipline after successful completion of four years with Discipline Specific Elective Courses in 7th and 8th semesters in lieu of Research Project and Dissertation, securing a minimum of 176 credits.

Four Year UG Programme with Honours with Research (BA, B. Sc, B. Com and Bachelor in other discipline) with single/double major: Students who wish to undergo a 4-year (8 semester) UG programme shall be awarded UG Honours with Research degree in the major discipline after successful completion of four years, with Research Project and Dissertation in 7th and 8th Semesters, securing 176 credits.

Academic Bank of Credits (ABC):

‘Academic Bank of Credits (ABC)’ is an academic service mechanism as a digital/virtual/online entity established and managed by MOE/UGC to facilitate students to become its academic account holders and paving the way of seamless student mobility, between or within degree-granting Higher Education Institutions (HEIs) through a formal system of credit recognition, credit accumulation, credit transfers and credit redemption to promote distributed and flexible teaching learning.

Student Registration: Students shall register themselves by visiting the ABC website and creating a student account through the concerned institution and records has to be submitted to the institution.

Academic Flexibility: ‘Academic Flexibility’ is the provision for innovative and interchangeable curricular structures to enable creative combinations of Courses/Programmes in disciplines of study leading to Certificate/Diploma/Degree of study offering multiple entry and multiple exit facilities removing the rigid curricular boundaries and creating new possibilities of life-long learning.

Credit accumulation: ‘Credit Accumulation’ means the facility created by ABC in the Academic Bank Account opened by the students across the country in order to transfer and consolidate the ‘credits’ earned by them by undergoing ‘courses’ in any of the eligible HEIs.

Credit recognition: ‘Credit Recognition’ means the credits earned through eligible/partnering HEIs and transferred directly to the ABC by the concerned HEIs.

Credit redemption: ‘Credit redemption’ means the process of commuting the accrued ‘credits’ in the Academic Bank Account of the students maintained in ABC for the purpose of fulfilling the ‘credits requirements’ for the award of Certificates/Diplomas/Degrees etc. by the degree awarding HEIs.

Credit transfer: ‘Credit transfer’ means the mechanism by which the eligible HEIs registered with ABC are able to receive or provide prescribed ‘credits’ to individual registered ABC account in adherence to the UGC credit norms for the ‘course/s’ registered by the desirous students in any HEIs within India. Inter- Institutional transfer of Credits may be considered by the Dibrugarh University on reciprocal basis or in compliance with the relevant Guidelines of the UGC. However, a candidate from other university has to fulfil minimum credit requirements as prescribed by Dibrugarh University.

CODE OF CONDUCT FOR THE STUDENT:

☐ **Uniform:**

A compulsory dress code for the students of the college follows:

Boys: White shirt and formal black pant

Girls: Mekhela-Chadar (white with green border and green blouse) or White Salwar- kurta with green dupatta.

- ☐ Mobile Phone is strictly prohibited inside the class rooms.
- ☐ Students must carry their Identity Cards.
- ☐ Ragging is strictly prohibited inside the college campus. The anti-ragging committee of the college takes adequate measures so that no incident of ragging takes place inside the campus.
 - (i) In case an applicant for admission is found to have indulged in ragging in the past or it is noticed later that he/she has indulged in ragging, admission may be refused or he/she shall be expelled from the college.
 - (ii) If any incident of ragging comes to the notice of the authority, the concerned Student (s) shall be given liberty to explain and if his/her explanation is not found satisfactory, the authority can expel him/her from the institution.
- ☐ Tobacco and liquor are strictly prohibited inside the college campus.

IDENTITY CARD:

The Identity card is issued to all students after admitting into the institution. The student must bring identity card while coming to the College. In case of original Identity Card is lost, the same may be re-issued by the authority on payment of Rs.200 (Rupees Two hundred) only.

UGC REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS 2009:

In exercise of the powers confirmed by clause (g) of sub-section (I) of section 26 of the

University Grants Commission Act, 1956, the UGC hereby makes the following Regulations:

1. Every public declaration of intent by any institution, in any electronic audio visual, print or any other media, for admission of students to any course of study shall expressly provide that ragging is totally prohibited in the institution and anyone found guilty of ragging and/or abetting ragging, whether actively or passively or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with these regulations as well as under the provisions of any penal law for the time being in force.

2. The application form for admission, enrolment or registration shall contain an undertaking mandatorily in English or in one of the regional languages known to the applicant in Annexure -I to these Regulations to be filled up and signed by the applicant and the parents/guardian in Annexure-II.
3. The institution shall constitute an Anti-ragging committee to take appropriate decision in regards to punishment or otherwise, depending on the facts of its incident of ragging and nature and gravity of the incident of ragging established in the recommendation of the Anti- Ragging squad.
4. The Anti-Ragging Committee may impose the following punishments depending on the nature and gravity of the guilt established.
 - (i) Suspension from attending classes and academic privileges.
 - (ii) Withholding/Withdrawing scholarship and other benefits.
 - (iii) Debarring from appearing in any Examinations.
 - (iv) Withholding results.
 - (v) Debarring from representing the institution in any regional, national or international meet, tournament, Youth festival etc.
 - (vi) Suspension/expulsion from the hostel.
 - (vii) Cancellation of admission.
 - (viii) Rustication from the institution.
 - (ix) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

GENERAL RULES:

1. The academic courses offered in N.N. Saikia College are full time courses. So, no students can take any other full-time course concurrently.
2. Students should keep their bicycle/motor cycle etc. in the proper allotted permanent shed
of the college.
3. No society can be formed in the college campus without any permission from the Authority. Without prior permission of the authority no person can be invited to a meeting in the college.
4. The college campus has been declared as tobacco free zone.
5. All students will be required to attend the classes and other activities in college uniform.
6. A student who fails to attend at least 70% of classes taught in a semester will be declared as dis-collegiate and will be debarred from appearing in the examination. Students having attendance within the range 70% to 80% will be treated as non-collegiate and are allowed to appear in the examination only on payment of Rs.700/- as fine.
7. Leave for participation in N.C.C. Camps, Debates, Quiz, Sports, and Cultural Programmes etc. are restricted as per college guidelines. The Principal must be given prior information in this regard.
8. Students applying for medical leave will have to submit a medical certificate issued by a
Govt. Doctor along with the application within a week of joining the classes.
